#### **HEIP Terms & Conditions**

Within 60 days of the home energy improvement materials purchase date and/or equipment installation date, you must apply for your rebates by submitting the proper documentation outlined on the online application. Certain restrictions apply. Must be a Georgia Power residential customer. All improvements must be completed at a residence with Georgia Power Residential service. Rebate reservation, preapproval, preconditions and requirements may apply. Valid January 1, 2023—December 31, 2025 with a signed Multifamily Reservation Acknowledgment. Rebates paid only on eligible improvements and on qualifying equipment and materials. If your improvement does not meet the preconditions and requirements outlined above, your application may be subject to rejection and non-payment. Full details available online. Georgia Power reserves the right to cancel or modify the rebate program at any time at its sole discretion. Please allow sixeight weeks from received date of a complete application for your rebate to arrive by mail. Multifamily rebates are capped at 50% of installed cost up to \$575 per year per unit for projects receiving 20% reduction and assessment rebates. Multifamily lncome Qualified Whole House rebates capped at 50% of installed cost up to \$1,250 for projects receiving 20% reduction and assessment rebates. Multifamily Income Qualified Whole House rebates capped at 50% of installed cost up to \$1,650 for projects receiving 35% reduction and assessment rebates. Multifamily Income Qualified Whole House rebates capped at 50% of installed cost up to \$1,650 for projects receiving 35% reduction and assessment rebates.

NOTE: Rebate amount and eligibility will differ for single family homes.
