The Georgia Environmental Protection Division (EPD) has completed its evaluation of the Certification of Decontamination and Completion of Closure activities and the Release from CCR Permit request submitted via GEOS 854619 on July 8, 2024 and revised on November 15, 2024. The enclosed Release from CCR Handling Permit is hereby issued, which officially designates the facility as closed and released. If additional CCR areas are discovered, EPD must be immediately notified, and the areas appropriately managed in compliance with applicable regulations.

This Permit Release does not relieve the owner/and or operator from complying with any other federal, state, or local requirements concerning the future use of the property.

This Release from CCR Handling Permit is now in effect; however, under Georgia Law it is subject to appeal for thirty (30) days following issuance and is subject to modification or possible vacation if appealed. Should an appeal be received within the 30-day appeal period, you will be notified immediately.

In accordance with the provisions of the Georgia Comprehensive Solid Waste Management Act, O.C.G.A. 12-8-20 (the Act) and the Rules for Solid Waste Management, Subject 391-3-4 (the Rules) promulgated pursuant thereto, this Release from Coal Combustion Residual (CCR) Handling Permit is issued for the following:

Coweta County – Georgia Power Company, Plant Yates Inactive CCR Landfill - Gypsum Stack – Permit Number 038-016D (CCR) located at 708 Dyer Road, Newnan, GA 30263 (Latitude 33.4664° N, Longitude -84.8994° W).

All statements and supporting data submitted to the Department of Natural Resources, Environmental Protection Division, have been evaluated, considered, and relied upon in the issuance of this Release from CCR Handling Permit.
